Minutes of the CUF General Meeting 9-21-10

Officer Lisa Johnson spoke. Discussed new safety brochures that went out as collaboration between Citizens on Patrol and Pomidori's. Also discussed the new prostitution crackdowns. Officer Lance Long from UC spoke about UC and the new students. Gave information about the dual cars and the UC Disciplinary code. His contact info is Lance.Long@uc.edu and 513-556-4927.

Tony Hobson from North American Properties spoke about the benefits of the 65 West Project at the old Friar's Club site. He unfortunately did not have any new plans to show the community as far as the facades. They are still seeking TIF money from the City for undergrounding utilities and for streetscapes.

CHCURC discussion. The Old St. George roof is still pending repairs. Nothing new on the boutique hotel. Discussion about the politics of the streetcar decision and our continued advocacy for the business district loop. Streetscaping continues on Ohio and Calhoun.

University Heights is having their annual block party on September 25th. They have already had their neighborhood yard sale.

Rome Ntogoku spoke about the Clifton Heights Music Festival. The greenspace will not be needed. Rome also decided not to pursue the liquor license. Extensive discussion with the community about graffiti art work. Clarified as StreetArt. The word graffiti has such a negative connotation and there was significant concern about the possibility for echos of graffiti to litter the neighborhood. Rome has already submitted the ads for the newspaper. At the end of the discussion, he would not commit to cancelling the Street Art exhibit at the request of the community.

Make A Difference Day was announced by Suzanne Summer for 10-23-10. Sign up by talking to or emailing Suzanne. Also discussion about the September 11th law school clean up and the subsequent poison ivy outbreak. Thanks to all who clean in their neighborhood!

The community discussed candidate night and has agreed that we will not have a candidate night before the election. Candidates are welcome to come and may leave their info at the entrance table and meet and greet afterwards. The Board

will confirm this decision at next meeting.

Fire prevention week was announced for Oct 3-9th.

Janine Denlinger represented our community at the city's search for a new Police Chief and a new Fire Chief.

CUF Family Picnic was announced for Saturday October 9th at 11:30 am, Bellevue Park.

Zoning variance changes were discussed as they had just come up at the last Liveable Communities Meeting of City Council. The new zoning code changes allow one person in the Buildings Dept. to make decisions about variances without the normal Zoning Board hearing and then approval by Council. There was significant concern about abolishing the Zoning Code, which is viewed as one of the few protections neighborhoods have. A straw poll of the community found the majority of the community was not in favor of changing the process for zoning variances. The Board will discuss at the meeting October 5th.

Landlord training program letter

Dear Madam or Sir:

Our records indicate that you own or manage rental property in Cincinnati, Ohio. Because of the problems associated with chronic nuisance and drug activity in rental housing, we are writing to you and other rental owners to invite you to a seminar, the Landlord Training Program, on how landlords and property managers can keep illegal activity out of their units. To date, thousands of landlords and property managers have attended the Landlord Training Program in other areas of the country. Now that the program is being offered for landlords in your neighborhood, we urge you to take advantage of it.

This program is part of an effort to stop chronic nuisance and drug activity in residential neighborhoods. While we use the Chronic Nuisance Ordinance (Chapter 761 – Cincinnati Municipal Code) and Permitting Drug Abuse (Chapter 911.5 – Cincinnati Municipal Code) to fine owners and close property in cases where the landlord has allowed nuisance activity to occur and drug dealing, distribution, or manufacturing on the property, we would prefer to work with landlords to ensure that problems never reach this level. Landlords who use techniques from the Landlord Training Program tell us the rewards outweigh the costs, and include the following:

- A stabilized, more satisfied tenant base, with increased demand for rentals.
- Lower maintenance and repair costs.
- Improved property values.
- Improved level of personal safety for both tenants and neighbors.
- Peace of mind from spending less time on crisis control.

Reactions from people who have taken this course have been very positive. Landlords tell us that the course provided them with new screening

techniques and helped them deal successfully with tenants involved in illegal activity. A recent survey indicates that more than 90 % of landlords who attend the training make changes in the way they manage their property as a result of the program. The program is also an effective community policing tool. Your attendance is encouraged. Thank you,

Recycling enhancements are coming!

The City is transitioning from small bins to larger carts to allow for the collection of a greater number and a larger volume of recyclable materials. Recyclables will now be collected every other week (EOW), instead of weekly.

All residents should have their carts delivered by the end of January/February. Changing to every other week collection will save the City approximately \$700,000 a year.

One and two person households will receive a 64-gallon cart; all others will receive a 96-gallon cart. Any eligible resident that doesn't receive a cart may call 591-6000 to request one.

I like my bin. Can I keep it? Maybe. You need to use a cart to participate in the incentive program. The carts will be equipped with Radio Frequency Identification (RFID) tags. This tag, similar to the scanning equipment at the supermarket, will allow the incentive program to reward points based on how often and how much you recycle. If you wish to keep your bin for overflow or to collect materials in your house, put a sign on the bin when the program is being "rolled out" in your zone and it will be left behind. If you don't want the bin, leave it at the curb and it will be picked up. Usable bins will be reasigned as needed. Damaged and broken bins will be recycled.

In 2009 City of Cincinnati residents landfilled

94,000 tons and recycled 13,000 tons of material. For every 10,000 tons we landfill 2 jobs are created. For every 10,000 tons recycled about 35 jobs are created. The enhanced program is projected to divert an additional 13,000 tons away from the landfill. By 2011 the City of Cincinnati is expected to landfill 81,000 tons and recycle 26,000 tons. This program will allow the City to save money on avoided landfill fees and waste collection, create jobs, reduce pollution, save natural resources, and save landfill space.

Lizard study

We'd like to send a big THANK YOU for all for the lizard sightings that you reported to our web site! I thought this was a good time to send you an update.

1) We received more than 300 lizards reports! (including yours) which completely changed our picture of the extent of spread on the introduced common wall lizard, a.k.a. "Lazarus" lizards. A graduate student, Ninnia Lescano, is preparing a paper a publication based on these results. To see a map of most of the sightings (some are outside the map's area) go to:

2) Help us more! Go to the web site again (<http://www.uc.edu/lizards>) and tell us:

(a) Have you seen lizards this year where you reported them in a previous year? This is especially valuable if you live OUTSIDE the core range, which is between Downtown and Clifton and Red Bank Rd.; south of I-71 and north of the Ohio river.

(b) Do you know how the lizards got to your neighborhood (or the site you reported)? At least 15 told us how lizards were moved to the site they reported. Knowing the year of introduction, numbers of lizards and their source would be very valuable. We do not encourage you to move lizards because introduced species should not be helped along, and any information you provide will be kept confidential. (Please also note that we do not harm any of the lizards or try to eradicate them).

3) Come to the Natural History of Cincinnati Conference October 16th. Speakers will include Thayne Maynard, anthropologists and paleontologists and yours truly who will be talking about the wall lizard, invasive species and your lizard reports.
