The current plan will change trash collection to every other week, much like the new recycling program. The Board is worried about the implications of this, and has written a letter to the Council and City Manager discussing our fears. In addition, there will be no yard waste collection. Remind your neighbors to pay attention to the recycling waste collection schedule so our streets are not littered with green bins for days and days. Maybe we should even look to do an educational walk through the neighborhood and educate households about the recycling program, as this has not yet been done in an effective way.

We also will have a markedly decreased budget for neighborhood operations. We will be decreasing our newsletter mailings. We will print hard copies for meetings and do limited delivery for those with no email, but most newsletters will be distributed via email. Please make sure we have a working email to contact you. We apologize for the inconvenience.

There are many good things on the horizon, as well. Classen Park continues and will finish this spring. The Clifton Heights Business District received the largest funding from the City for Neighborhood Business District improvements. Towne and Neyer are partnering and looking to start showing the neighborhood the plans for the lots between Calhoun and McMillan. The cleaning of the roof and rafters of Old St George has begun, and the roof will be repaired this spring. The City has engaged the community on a potential parking permit system for our neighborhood. Look for beautiful new plantings along Ravine in front of St Monica, designed by one of

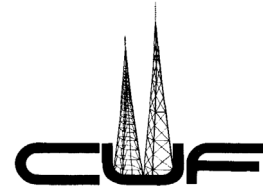
our own amazing neighbors. And we continue to have excellent support from our neighborhood police.

CUF Community Fund
Membership Requirements

To be a member of the CUF Community Fund, one must be a paid member of the Clifton Heights, University Heights and Fairview Neigh-

borhood Association (CUF) for 24 months prior to the annual meeting of the members and must be a permanent resident residing within Clifton Heights, University Heights or Fairview as designated in the by-laws of the CUF Neighborhood Association, Inc., or its successor organization. A permanent resident is defined as one residing year round within the CUF community for at least four consecutive years (48 months) immediately preceding the consideration of Member status. The burden of satisfying the requirement of permanent residency is upon the individual seeking to be a member.

Personal invitations will be mailed to individuals that satisfy the first requirement for membership. (Paid member of CUF for 24 months prior to the annual meeting). Invitations will designate which individuals will need to provide proof of permanent residency.

The members of the Board of the CUF Community Fund wish to extend to all members of the CUF community a happy, healthy, safe and prosperous New Year.

RNCC volunteer nominations

The Host Planning Committee for the Regional Neighborhood Network Conference (RNCC) is accepting proposals through February 4, 2011, for community volunteer nominations for its Stella Stewart "Doing Good in the Neighborhood Award" to be presented at the

next conference planned for September 22-24, 2011 at the Hilton Netherland Plaza Hotel.

The Stella Stewart "Doing Good in the Neighborhood Award" was created in 2005 as a means to highlight the positive and ongoing efforts of citizens in a participating Regional Neighborhood Network city who are making exceptional contributions to improve the quality of life in their neighborhoods. Award recipients must have been active a minimum of five years and should embody the spirit of a true neighborhood leader who goes above and beyond the call of a typical volunteer-oriented assignment. The Stella Stewart Award is a posthumous honor recognizing Mrs. Stewart, a long-time representative of Lexington-Fayette Urban County Government at previous conferences.

Nominations will be reviewed by the Steering Committee of the Regional Neighborhood Network. Submissions must be in their entirety in the required formats by the deadline date. City of Cincinnati - yard waste collection service

OPERATIONS UPDATE: The City of Cincinnati is suspending curbside collection of yard waste from homes and businesses.

- * Beginning January 17, 2011, yard waste will no longer be collected as a separate service.
- * Garbage collection will continue to occur on regularly scheduled days. This service remains unaffected.
- * Citizens are encouraged to engage in alternate, environmentally-friendly uses for their yard waste, such as composting and mulching whenever practical.
- * Yard waste that is mixed with regular garbage will be collected as part of the regular garbage collection, but citizens are encouraged to opt for greener methods of disposal. Basic information about backyard composting and a downloadable brochure for beginners are available at:

- * Several yard waste drop-off sites are in operation across Hamilton County. Residents are strongly encouraged to utilize these free sites to supplement their regular yard waste collection service.

YARD WASTE DROPOFF LOCATIONS:

- * Central: West Fork Solid Waste Facility - 3320 Mill Creek Road, South Cumminsville, for Cincinnati residents only. Accessible off Spring Grove Avenue and off Beekman Street. Open year-round Monday through Friday, from 7:00 a.m. to 3:00 p.m. (excluding holidays)
- * East: Bzak Landscaping - 3295 Turpin Lane (off Rt. 32), Anderson Township January 8 and January 15, 2011, from 12:00 p.m. to 3:00 p.m. Opening again in Spring
- * West: Kuliga Park - 6717 Bridgetown Road, Green Township January 8 and January 15, 2011, from 12:00 p.m. to 3:00 p.m. Opening again in Spring
- * North: Rumpke Landfill - Struble Road and Colerain Avenue, Colerain Township January 8 and January 15, 2011, from 12:00 p.m. to 3:00 p.m. Opening again in Spring.

Unified Development Code

In October the City of Cincinnati received a \$2.4 million grant to help update the city's Unified Development Code.

The development of the UDC will replace all existing development regulations. Recognizing the diverse development challenges of Cincinnati, including social, environmental, and economic challenges, the UDC will provide a set of development regulations that codify the recommendations of Plan Cincinnati (see below) and more detailed corridor and district plans while facilitating sustainable development and simultaneously being responsive to a divergent set of community interests.

The UDC will incorporate the following methods and considerations in the development of a holistic set of recommendations: Form-Based Codes, Inclusionary Zoning/Fair Housing, Incentive Zoning, Transit-Oriented Development, Accessibility/Visibility, LEED-ND®, Environmental Regulations, Transfer of Development Rights, Crime Prevention Through Environmental Design (CPTED), Airport Overlays, and Site Plan Review. A formal Site Plan Review process will be developed to promote efficiency and consistency in project review and will ensure that City departments are working cooperatively to implement the Livability Principles.

Plan Cincinnati

The City is creating a new Comprehensive Plan for future growth and development. Currently, a number of large projects are underway that will impact the City of Cincinnati.
