## **Lower Your Utility Bill**

Nobody likes to see utility bills go up in the winter, but you can do more about it than just lowering the thermostat and putting on another sweater. You can go to the root of the problem. "About 45 percent of a residential utility bill deals with the cost to heat or cool a home, and approximately 50 percent of energy loss in a house occurs through the attic," said Toni Winston, President of Tiburon Energy & Construction, a company partnered with the Greater Cincinnati Energy Alliance, a nonprofit working to improve energy efficiency in homes and commercial buildings.

"It's normal and healthy for fresh air from outside to come into a house as house air exits." said Winston. But how frequently should this air exchange occur? When the turnover occurs too often, heat loss is excessive, and utility bills are higher than they need to be. The optimum fresh air intake is unique to each house and varies with its size, number of stories, etc. An energy audit calculates the optimum for a home, pinpoints where the greatest heat loss is occurring, and identifies how the homeowner can get the biggest bang for the buck in addressing the problem. Besides reducing heating bills, homes become more comfortable: dramatic temperature differences from one floor to the next disappear, and the house is quieter because the furnace isn't cycling on and off as often.

"An energy audit takes about three hours, and at the end, the auditor can tell you your anticipated savings," Winston said.

The Greater Cincinnati Energy Alliance and its partners offer a range of rebates, discounts, financing, and tax credits to encourage homeowners to undertake energy audits and home improvements targeting heat loss and energy efficiency. Anyone in Hamilton County in Ohio and Butler, Boone, and Kenton counties in Kentucky can participate in these programs without restrictions based on income.

While Ohio is not yet among the states that require energy audits as part of buying and selling a home, the trend is spreading nationally.

Check out the Greater Cincinnati Energy Alliance at http://greatercea.org/, and while you're thinking about your utility bill, go ahead and turn down the temperature: Duke Energy says you can save as much as three percent on your energy bill for each degree you lower the thermostat.

#### Police Report, Officer Lisa Johnson

Officer Johnson reported that there have been a number of car break ins on Riddle Road. Home break ins were made by an individual who took stolen items to Covington in order to pawn them.

Flyers were distributed with photos of various suspects in criminal actions. A list of important phone numbers was also provided along with forms for residents to prepare that would allow access to their property by police officers in the event of an incident or suspicious behavior.

The property at 2312 Flora was identified as having problems with out of control partying.

Officer Johnson emphasized the importance of sending her emails reporting the details of incidents. This allows her to take up the issues with landlords.

Arrests were made at 630 Straight Street involving drugs, weapons and large amounts of cash. One suspect is a fugitive with outstanding warrants.

#### **Guest District Fire Chief Fred Prather**

Chief Prather made a presentation on home fire safety. He discussed the importance of having both smoke and carbon monoxide detectors. Residents can call 357-7585 to obtain detectors. All firefighters are also certified inspectors. Residents can call if they want an inspection. The department has the ability to prosecute where there are violations. There are two types of detectors - photo electric and ionization alarms. The former are typically used in bedrooms and living rooms. The ionization units detect flaming fires. Residents should be aware of manufacturer's recommendations and units should be replaced at least every 10 years. Batteries should be replaced every 6 months. Chief Prather also emphasized the importance of having disaster preparedness kits as well as an escape plan in case of fire or other emergency.

#### **Fairview Pool**

Meeting the Cincinnati Recreation Commission is scheduled for the week of Jan 21 at Fairview Pool. The purpose is to survey the area and outline potential improvements.

Campus Safety Committee

A safety meeting with UC, police and CUF is scheduled for January 18. This is not a public meeting but Cherie Wallpe will represent the CUF Neighborhood Association.

## **Local School Decision Making Committee** (LSDMC)

CUFNA representative Chip Kussmaul reported that the Hughes HS is looking for a permanent principal.

At the District 5 Community Resource Meeting January 14, it was decided that future meetings will be held semi-annually.

#### **Building and Inspections**

#### **Guest: John Walter, Lower Klotter Street**

Mr. Walter and neighbors in the lower Klotter area partnered and purchased surveillance cameras for neighborhood security. The action was in response to 40 reported crimes in a short period of time. The owner of a property in foreclosure gave the keys to a drug dealer. This resulted in a large number of break ins and other problems. The neighbors raised funds and also received a grant from Keep Cincinnati Beautiful. They may add additional cameras in the future. The camera is not used in real time but if there is an incident, the recording can be retrieved for visual information. They would like to get the camera on-line at District 1.

## Guest: Kimberly Naumann, Christ the King Congregation

Christ the King Church on Warner Street will host a health fair on April 13. It will focus on Diabetes and obesity issues. In the future, they would like to establish a weekly Saturday clinic.

The congregation also can do bicycle repairs and is attempting to get donated bicycles for children that they can refurbish and distribute.



#### CUF Community Fund Membership Requirements

To be a Member of the CUF Community Fund, one must be a paid member of the Clifton Heights, University Heights and Fairview Neighborhood Association (CUF) for twenty-four months prior to the annual meeting of the Members and must be a permanent resident residing within Clifton Heights, University Heights or Fairview as designated in the by-laws of the CUF Neighborhood Association, Inc., or its successor organization. ## **Bike Share Program**

Cincinnati has issued a Request for Proposals for a Bike Share System Operator. The City is seeking a company to fund, own, and operate a bike share system in Downtown and OTR.

In a bike share system, public bicycles are available to rent on-demand at fully automated stations located conveniently throughout the city -- fast and convenient access for any trip that's too long to be easily walkable but too short to require the use of a car or public transit. You can pick up a bike close to home or work, ride to your destination, and then return the bike to any nearby docking station.

Bike share systems typically consist of several bicycle rental stations, with 10-12 bicycles per station. The stations accept credit card payment for rental, with the rental cost determined by the length of use. Bicycles can be returned at any station location – not just the one where you picked it up.

Bike share programs have been implemented in cities across the country, including Washington DC, Boston, and New York City.

Last fall Cincinnati completed a feasibility study identifying the best way to implement a successful bike share program in the city. The study recommended 21 station locations in the Downtown/OTR area.

Station locations were determined through an analysis of potential demand based on where people live, work, play and shop, and the desire to travel between these places. Public input through a collaborative mapping website also played a significant role in determining the recommended station locations. The stations with the most public support included those at Washington Park, Fountain Square, Findlay Market, the Purple People Bridge, Union Terminal, and Government Square.
