Dear Friends and Neighbors,

Monthly CUF update:

On Saturday, April 30, CUF participated in the annual Green-Up Day sponsored by the Parks Department. Some years ago, an unattractive corner at Warner and Chickasaw Streets was landscaped with retaining walls and plantings by area residents. At this point, the corner was in need of sprucing up. So, weeds were removed, shrubs were pruned, new soil was filled in where needed, sedum was planted, and finally the entire corner was mulched. A row of lilies is planned in front of the wall to discourage people from driving over the ground. Thanks to Paul Gallagher, Mark Bambach and our youngest gardener, Stanley Wilson, for their efforts.

The owner of a building on lower Ravine had applied for a demolition permit. According to the terms of our Interim Development Control District, notice was sent to CUF and the matter was heard by the Planning Commission on May 6. Apparently the hillside behind the house is slipping, and it was feared that tearing down the building would aggravate the situation. A decision on the matter was postponed pending further investigation.

We have received some information from ArtWorks on prospective artists for our mural project on Central Parkway this summer. If all goes well, the canal-themed mural will stretch from north of Straight Street to a bit beyond Marshall Avenue. See some of the artists' work at:

The University of Cincinnati continues its search for a Chief of Police and an Assistant Chief of Police. They are asking for input from

Lead in drinking water is a huge concern these days. Staff from the Greater Cincinnati Water Works are contacting area community councils to schedule visits. Representatives from their speakers' bureau will present information to us at the June general meeting.

The May meeting will have a law enforcement focus. Two detectives from the Cincinnati Police will present information on the Cincinnati Citizens Respect Our Witnesses (CCROW) program, aimed at encouraging participation in the criminal justice process toward the end of increasing successful prosecution of criminals. The UC canine unit, complete with their human officers, will also introduce themselves to us and explain their functions.

One more reminder, our consultant is now engaged in researching a possible historic district in CUF. She is interested in old photographs of Clifton Heights. Do you know a teenager needing service hours this summer for school credit? Do they enjoy the outdoors and spending time with children? Are they at least 13 years old? If so, we have half day and full day opportunities for them to volunteer this summer in our Nature Day Camps at Ault Park, Burnet Woods, California Woods, Downtown Riverfront Parks, French Park, LaBoiteaux Woods and Stanbery

Park.

From June 13 through August 12, Our Counselors In Training (CIT) volunteers assist group leaders with a variety of activities such as providing extra direction during games, giving an extra hand during crafts, being the "caboose" and additional watchful eye during hikes and setting a good example for campers. Youth 2 Work Program

The City's Youth 2 Work Program is a consortium of City departments, local nonprofits, and partner organizations working to recruit, train and employ youth on behalf of the City of Cincinnati.;

The 8-week program provides job readiness and life skills training to Cincinnati youth between the ages of 14-18 through internal City Departments or outsourced organizations. Youth will work between 20-30 hours a week from June to August earning \$8.10 per hour (the current minimum wage for youth in Ohio).

Employers include City departments, nonprofit organizations, and private sector partners. Youth are placed in career-oriented employment opportunities such as law enforcement, fire and safety, horticulture, recreation, art, technology and administration.

Safe drinking water remains top priority for GCWW

CINCINNATI – Your water is safe.

That's the message the City of Cincinnati and Greater Cincinnati Water Works (GCWW) wants to clearly articulate to residents of the region.

GCWW provided in late January a detailed overview of the special situation in Flint. At that time it also offered reassurance to the public that providing and maintaining safe drinking water to customers throughout southwest Ohio and parts of Northern Kentucky is the top priority of GCWW.

In short: They made it clear the water situation in Flint does not exist in Cincinnati.

“For nearly 200 years, Greater Cincinnati Water Works has been a dependable provider of safe drinking water for the Greater Cincinnati region. [Water Works] has always met or exceeded all of the state and federal health standards for drinking water and uses state-of-the-art water treatment processes that include multiple barriers to protect public health,” wrote City Manager Harry Black in a memo to Mayor John Cranley and members of Cincinnati City Council.

The memo, submitted to Council on Friday, Feb. 19, outlines the manner by which GCWW treats and tests the more than 48 billion gallons water it provides to 235,000 customers across the Greater Cincinnati region every year. Multiple treatment processes are practiced now to ensure there is no lead in the water as it leaves the treatment plants and flows through the distribution pipes.

GCWW's highly trained staff test the water more than 600 times every day.

“As required, GCWW treats the drinking water specifically to prevent lead leaching into the drinking water. This treatment process is called lead corrosion control and ensures there is no lead in the water as it leaves GCWW treatment plants and flows through distribution pipes,” the City Manager added. “Additionally, GCWW undergoes a stringent testing program to ensure that the treatment is effective.”

Even with a litany of testing and safety measures in place, GCWW continues to enhance its current programs through additional education and outreach and initiating new solutions to further minimize lead service lines in the distribution system. Removing the public portion and private portion of lead service lines is a priority now and for years to come.

“GCWW will seek ways to improve the lead service line replacement program, including assistance programs for customers,” City Manager Black wrote. “These solutions will greatly reduce risks and further enhance the system for years to come so GCWW can continue to deliver the highest quality, safe drinking water to the region.”

The detailed memo from the City Manager also provides information on the regulatory standards in place regarding lead and copper pipes, the responsibility of replacing antiquated pipe systems, and future plans for addressing any systemic issues and ensuring the safety of those who drink Cincinnati's award-winning water.

The City Administration is working to schedule a full presentation of these recommendations to the appropriate City Council Committee.
