PRE-EVENT EMERGENCY PREPARATION

Gathered intel from social media

Collaborated with available resources (CFD, UCPD, UCPIO, UC Student affairs Buildings and Inspections, City Law Department)

Hand delivered resident warning letters from the city Law Department, regarding nuisance abatement action for Flora and Victor Fest.

Delivered warning letters and contacted the three DJs via telephone, rumored as being hired for the event. None of the DJs showed up for neither Flora or Victor Fest

PRE-EVENT EMERGENCY PREPARATION

District Building Inspector and their personnel were present and met with student residents

Dispatched extra police personnel for crowd management and intelligence gathering for Administrative (via UC Student affairs), Criminal, and Civil action



ACTION TAKEN DURING THE EVENT

Distributed warning letters to households observed setting up music entertainment Litter Control was on scene observing properties where violations might be anticipated and warned residents of potential fines.

Officers increased engagement and warnings to participants during the early stages of Victor Fest. The streets remained relatively clear and passable, throughout the duration of the event.

CFD monitored houses throughout the night for fire code violations and took photographs

ACTION TAKEN DURING THE EVENT

Crowd Management

observed and facilitated the situation without unnecessarily inflaming an intoxicated crowd. That approach could have potentially fueled unrest, and created an unnecessary safety risk to the officers, and damage to the community on a broader scale. Additional officers were available for **Crowd Control**, if needed, per Cincinnati Police procedure 12170.



ACTION TAKEN DURING THE EVENT

CINCINNATI FIRE DEPARTMENT

MONITORED HOUSES THROUGHOUT THE NIGHT FOR FIRE CODE VIOLATIONS AND TOOK PHOTOGRAPHS

ACTION TAKEN DURING THE EVENT

- OFFICERS USHERED THE COMPLIANT CROWD TO WEST MCMILLAN STREET, WHERE THEY QUICKLY DISPERSED WITHOUT INCIDENT
- MANY OF THE STUDENT RESIDENTS CLEANED UP IMMEDIATELY AFTER THE EVENT



POST EVENT FOLLOW UP

- CITY ABATEMENT/SANITATION PERSONNEL IMMEDIATELY WENT INTO ACTION THE MORNING AFTER AND ADVISED STUDENT RESIDENTS WHO PARTOOK IN THE EVENT.
- STUDENT RESIDENTS BEGAN A CLEANUP ALONG THE EXTERIOR OF THEIR PLACE OF RESIDENCE.
- LITTER CONTROL ISSUED NINETEEN CITATIONS TO RESIDENTIAL PROPERTY OWNERS,
 TOTALING \$8,000 IN FINES.
- CPD AND UCPD OFFICERS MET WITH AND IDENTIFIED TENANTS FROM PROPERTIES
 CITED. THE TENANT INFORMATION WAS REPORTED TO UC STUDENT AFFAIRS FOR
 REVIEW, IF THE INDIVIDUALS WERE IDENTIFIED AS ENROLLED STUDENTS



POST EVENT FOLLOW UP

 THE OWNERS OF THE DAMAGED VEHICLES, DID NOT RESPOND TO OFFICER DENT'S REQUEST TO SPEAK WITH THEM.
