Dear Neighbors,

The CUF Neighborhood Association is interested in ideas for projects in 2024. We have two funding sources: the Neighborhood Support Program (NSP) from the city budget and an Annual Interest Grant (AIG) from Invest In Neighborhoods. The process involves a proposed idea, approval by the CUFNA board of trustees, estimate of costs involved, submission of receipts after completion of the project, and finally reimbursement.

Typically, between \$8,000 and \$10,000 is allocated each year from NSP to Neighborhood Associations throughout the city. The AIG grant is usually less than \$1,000.

Funds can be spent in these categories:

- 1. Neighborhood Leadership Development Activities - that strengthen, improve, and develop neighborhoods through human development activities.
- 2. Communication Projects specific or general activities that seek to inform, educate, and publicize the work of the Community Council, special activities, or events.
- 3. Neighborhood Improvement Activities that focus on cleanup and beautification, recreation area development, conservation, capital improvements (not private property), and the acquisition of fixed assets.
- 4. Educational Activities which seek to enhance existing programs or opportunities, inform residents of new neighborhood initiatives such as environmental or development issues, or to create new programming that will fill an education void for youth, teenagers, adults, or senior citizens.
- 5. Neighborhood Services designed to aid law enforcement, develop or enhance recreation opportunities, stimulate economic or commercial development, or manage, study, or promote environmental issues.
- 6. Problem-Solving Projects to investigate

problems or conditions in an effort to develop a comprehensive plan to improve or alter situations communities deem a priority.

We have developed a survey that residents can use to make suggestions. We will be publishing it in September and October and then make decisions at the November meeting.

The City of Cincinnati's Department of Community & Economic Development (DCED) offers a wide variety of programming throughout the year to invest in the vitality and success of our city's neighborhoods, businesses, and residents.

The following programs are currently accepting applications:

Cincinnati Commercial Tenant Improvement Program (CCTIP)

The goal of this new program is to reduce financial barriers small businesses face when securing commercial space.

Through CCTIP, DCED will grant up to \$20,000 for tenant improvements to small businesses (1) relocating to Cincinnati, (2) opening a new business in Cincinnati, or (3) expanding within Cincinnati.

The deadline to apply is 5 P.M. EDT on Monday, September 18, 2023.

Neighborhood Catalytic Capital Investment RFP (NCCI)

After a successful first round of projects, DCED is excited to announce the continuation of NCCI with applications now open to a second round of transformative projects across Cincinnati. The NCCI RFP targets transformative neighborhood proposals requiring predevelopment resources needed for future construction.

The deadline to apply is 12 P.M. EDT on Friday, October 20th, 2023.

Notice of Funding Availability Loan Program (NOFA-B)

DCED is celebrating a decade of our NOFA program with a new round of applications for transformative housing projects making a positive, visible impact on our communities. NOFA, a public gap financing tool, leverages private financing to develop quality housing throughout the city.

NOFA loans are awarded through a competitive application process through which DCED staff evaluate and recommend projects based on how well they meet the City's

housing policy objectives; we especially intend to support projects that help to provide a full spectrum of healthy housing options, improve housing quality, and increase affordability. The required 'Intent to Apply' form deadline is 3 P.M. EDT on Friday, September 15th, 2023. The companion NOFA-B Application deadline is 3 P.M. EDT on Friday, October 13th, 2023. Ohio Historic Preservation Tax Credit (OHPTC) Program

In a historic city like Cincinnati – where our housing stock consistently ranks in the top 10 cities for the oldest housing inventory in the nation – programs that catalyze historic preservation of housing are instrumental. OHPTC is a highly competitive state-level program providing tax credits to leverage private redevelopment of historic buildings. Applicants can receive a tax credit up to 25% of qualified rehabilitation expenditures incurred during a project.

Applicants file an application with the Ohio Development Services Agency and historic rehabilitation documentation with the State Historic Preservation Office. Submissions are received bi-annually in March and September. DCED can help by providing a local 'letter of support' to make your application more competitive. The deadline for the current round of request forms for a letter of support is 4 P.M. EDT on Friday, September 15th, 2023. More info and application details can be found here.


